I waive any claims, demands, causes of actions, or any claims for relief whosoever against, and release Cranberry Portage Winterfest (as well as any Cranberry Portage Child/Family Resource Center employees, board members, volunteers, or third-party vendors) from any and all liability, claims and/or causes of action that I may have for injuries or other damages arising out of the participation in Cranberry Portage Winterfest, including but not limited to events, and activities.

Indemnification:

I recognize that there is risk involved in the types of activities offered by Cranberry Portage Winterfest. Therefore, I accept financial responsibility for any injury that I may cause either to myself or any other participant due to negligence. Should the above-mentioned parties or anyone acting on their behalf be required to incur attorneys' fees and costs to enforce this agreement, I agree to reimburse them for such fees and costs. I further agree to indemnify to hold harmless Cranberry Portage Winterfest, the Cranberry Portage Child/Family Resource employee, board members, volunteers, and third-party vendors from liability for injury or death of any persons and damage to property that may result from my negligent or intentional act or omission while participating in activities and events offered by Cranberry Portage Winterfest.

I have fully read and understand the forgoing of assumption of risk, the release of liability, and I understand that by signing it obligates me to indemnify the parties named for any liability for injury or death of any person and damage to property caused by my negligent or intentional act, or omission.
